KEY UPDATES:

- Wipro announces leadership changes across the board, acquires Healthplan Services for \$460 M
- Dell Services, formerly Perot Systems, is sold to NTT for a little over 3 BN
- IBM's Watson Health unit acquires Truven Health Analytics, a provider of healthcare data integration and analytics solutions for US \$ 2.6 billion
- GE Healthcloud launch names TCS and Cap Gemini as SI partners
- Cognizant to develop TranZform, a healthcare data integration platform leveraging Trizetto and Orion Health technologies

ACCENTURE

- 1. Accenture Federal Services has recently entered into a two-year consulting agreement with ONC to help government agencies create a framework to collect, analyze and leverage the Patient Generated Health Data (PGHD). Accenture will, during its service contract, determine best practices, challenges, success stories and do a gap analysis with the objective of integrating the PGHD data with the clinical records and to improving the overall clinical care, and lastly contribute to research.
- 2. The 43rd U.S. Army Surgeon General Horoho will lead Accenture defense health practice and oversee business strategy, growth and operations.





CAPGEMINI

Capgemini, named a GE Health Cloud Partner, will leverage its business and digital expertise for its work on Predix to provide consulting and end-to-end solutions on the GE Health Cloud.

COGNIZANT

Cognizant is developing a technology solution named Cognizant Health TranZform, which aggregates data from multiple systems, including Cognizant's TriZetto payer core administration platforms, physician practice management systems, EHRs and other healthcare databases.

The solution is being developed with technology from Orion Healthcare and it can provide consumers with information – such as costs for procedures, ratings of doctors, locations of health clinics, and data that is relevant to their specific conditions or care regimens. This should help "consumers make better-informed decisions about the cost and quality of their care while assisting healthcare providers and payers to drive greater levels of consumer engagement, satisfaction and operational efficiency."

DELL

- 1. Dell's IT consulting division, formerly Perot Systems, has been purchased by NTT for just over \$3 billion. This helps Dell shed its non-core business to fund the \$67 Billion EMC acquisition slated for October 2016. NTT Data has its North American headquarters in Plano, TX.
- 2. Dell announces IT outsourcing deals with Dubai Health Authority, Blue Cross & Blue Shield of Rhode Island, Harvard Pilgrim Healthcare and Baystate.

GE HEALTHCARE

GE Healthcloud welcomes new partners, launches new apps to ecosystem connecting 2M imaging systems worldwide. The GE Health Cloud system built exclusively for the healthcare industry will connect more than 2 million imaging machines worldwide and will provide cloud-based analytics for IT professionals.

WIPRO

- 1. Signed an agreement to acquire 100% of shares in Tampa, Fla. based HealthPlan Services from Water Street Healthcare Partners. This deal is worth \$460 million. HealthPlan services offer technology platforms and fully integrated BPSaaS solution to health insurance companies in international, group and ancillary markets. Wipro expects to be a leader in administrative services in US Healthcare Insurance with this deal
- 2. Wipro appoints Patrick Dupuis to its board of directors he brings with him a valuable experience of being a leader of BJC Healthcare apart from other industries where he has proven financial and business strategies acumen.

- 3. Dr. Patrick J. Ennis, a widely respected technologist and venture capitalist is appointed to Wipro's Board of Directors, effective, April 1
- 4. TK Kurien was appointed as the Executive Vice Chairman and Abidali Z Neemuchwala as the Chief Executive Officer and Member of the Board of WIPRO
